President's Message

Looks like Winter remembered us here in Norfolk County. This President's Report reiterates much information on how the Board is handling the AGM, membership renewal and voting on previous AGM minutes, 2020 year end financials and election of Board members.

As mentioned in the last NWOA Newsletter the March 3, 2021 AGM will not take place as we were accustomed to in the past at the German Home in Delhi. We hope to return there in 2022, time will tell.

The NWOA is required to conduct an AGM within 6 months of year end. This year, the NWOA must hold the AGM by June 30th, 2021. The AGM in the past had three components lumped into one event:

- Membership renewal tied to the Early Bird Draw and Door Prizes.
- Membership voting to accept the previous AGM minutes and Financial Report, and election of Board members.
- Gathering of members to further their woodlot education by speaking with vendors and groups involved with various aspects of woodlot management, listen to guest speakers, and share anecdotal knowledge.

Since we cannot gather as we have in the past, this year's AGM will happen in a Covid-19 friendly manner, from a distance. The 2021 AGM is more definitively divided into three components:

A January AGM package was mailed out on Jan 15, 2021. You should have received this package by the end of January and included the following,

- Membership Application/Renewal Form, which when completed and mailed back prior to March 1, 2021 is eligible for the Early Bird Draw (prizes include chain saw and office chair).

February AGM package that includes the following,

- 2. A Proxy Vote Form to indicate your acceptance (or not) of the items below. This replaces the in-person Business portion of our normal AGM.
- 3. Minutes of March 3, 2020 AGM. Please let us know if any changes are required and forward back to us. Otherwise accept or not on the Proxy vote form.
- 4. Dec 31, 2020 NWOA financial statements. Please let us know your proxy vote to accept or not.
- 5. List of current Board members.
- 6. List of nominees. Please let us know your proxy vote to accept or not.
- 7. Please note that each completed and returned Proxy Vote Form (one per member) is eligible for a draw on the door prizes so generously donated by local merchants and organizations to NWOA AGM.

The third, or fun part, gathering of members at the German Home to further their woodlot education with informative guest speakers, vendor and organization displays and conversation, will instead happen throughout the year in a different format. The Board plans on ramping up field trips and woodlot tours when we can safely gather again and will offer webinars on forest related topics through the Microsoft Teams platform. These will take place throughout the remainder of the year.

NORFOLK WOODLOT OWNERS ASSOCIATION Minutes of the ANNUAL GENERAL MEETING WEDNESDAY March 4, 2020 Delhi German Home

NWOA President, Mr. John de Witt, opened the meeting at 7:00pm.

There were one hundred & fifteen people attending the meeting.

Mr. de Witt recognized the presence of a local member of government. He also thanked exhibitors and those who have donated time and prizes that help make the AGM a success. In particular, he thanked Premier for the chainsaw, to which the NWOA also donated, and Tim Hortons for the refreshments.

Mr. de Witt mentioned a trifold that can be used for familiarization about NWOA is available to attending members. Tracey Boerkamp moved to confirm Remus Lukosius and Luke Haze as Directors. Angelle van Kleef seconded. Motion carried. Dr John Morrissey moved to approve the Minutes of the 2019 AGM. Betty Chanyi seconded. Motion carried. Mr. de Witt acknowledged the work of Eric Ferguson and Tracey Boerkamp for their efforts in organizing the AGM as well as the other Directors for their contribution to the Association.

Mr. de Witt invited members to participate in sharing what is of interest to them on the website. He thanked Kristen Bernard and Dan Marina for their work in providing material that may be of interest to woodlots on the website.

2019 Minutes - The Minutes of the 2019 AGM were reviewed. Dr. John Morrissey moved that they be accepted. Anne Wynia seconded the motion. The motion was carried.

Financial Report - Eric Ferguson presented the Financial Report. The Opening Balance for 2019 was \$17,413.62. Membership dues from members for the year were \$4,921.06. There was a donation of \$100.00. Total Revenues were \$5,021.06. Expenses for the year were \$5,963.99, leaving a Book Balance of \$16,470.69 as at December 31, 2019. Tracey Boerkamp moved to approve the report. Angelle van Kleef seconded the motion. The motion was carried

Election of Directors – John de Witt conducted a nomination of new Directors. There were no nominations. **Speaker** – Dr Christian McQuarry of Great Lakes Forestry Centre, provided a presentation on Management of Emerald Ash Borer (EAB) and work done with Townsend Lumber. He reported that firewood is the most common means of moving Emerald Ash Borer. He informed that feeding under bark destroys the tree. It akes one to two years to complete the cycle of pupation. Climate influences the development of population. Treatments require injection into trees. Management uses natural enemies of EAB to attack larvae or eggs. Research has been introducing natural enemies since 2013. Research is beginning on resistant and resilient ash tree species. Dr McQuarry reviewed the work done with Townsend Lumber on using a systems approach to managing the processing wood products. Lumber was sampled as it was being processed. The final process reveals the risk of EAB infestation is zero. Heat treated slabs revealed no insects at 54°C or greater. The next steps in research will be to apply similar processes to manage bronze birch borer.

Mr. Adam Biddle provided an update on Gypsy Moth. Severe outbreaks were restricted to a few areas. There is a lower prediction for 2020. The County conducted surveys in woodlots. He noted that there are possible high levels in the same areas as 2019. The County also conducted a study of forest cover in the county. The results show that 23.94% of the County is forested and 86.13% of that is on private land. He noted that only .7% is within urban boundaries. This report is based on data provided to him. The County's objective is to conserve natural heritage by identifying significant woodlands and providing forest conservation bylaws. This is done by regulating destruction, clearing and issuing permits. He reported that there are 100 to120 harvests per year. Exemption permits vary from year to year between 2 and 10 per year. The leading justifications for exemptions are for agricultural use. The County will be reviewing the bylaws in 2020. Woodlot owners are encouraged to continue to be aware of recommendations and provide feedback.

Early Bird Prizes - Tracey Boerkamp announced the winners of the Early Bird Door Prizes – a Stihl chainsaw, donated by Premier Equipment, was won by Mary deCloet.

Mr. de Witt thanked attendees for their continued interest in the NWOA, sponsors of the meeting, presenters, booth holders and Dan Marina of Norfolk County for providing the technical support for the meeting. He informed association members that there were many gifts provided by sponsors, who were identified, which could be collected at the close of the meeting.

Dr John Morrissey motioned to adjourn the meeting at 9 pm.
